### FIELD OF MEMBERSHIP REQUIREMENTS:

- For your business to qualify for membership, it must meet **one** of the following criteria:
  - Filed with the Idaho Secretary of State and operating in Idaho or
  - Filed in Washington and located within a Washington School District or
  - Filed with the Oregon Secretary of State and located within <u>one</u> of the following Oregon counties: Baker, Malheur, Umatilla, Union, or Wallowa <u>or</u>
  - Filed with the Arizona Secretary of State and located within <u>one</u> of the following Arizona counties: Cochise, Pima, Greenlee, Grahm, Santa Cruz, or Yuma <u>or</u>
  - Filed with the Arizona Secretary of State and a member of "Friends of Sabino Canyon" association or wishes to make a \$25 donation to become a member of the "Friends of Sabino Canyon" association

#### **INFORMATION REQUIRED TO OPEN MEMBERSHIP:**

- Personal Identification Must be a Government-Issued I.D.
- Business Tax Identification Number or EIN
- Business Documentation varies by state, see below

    - Idaho: Statement of Partnership or Current Annual Report or Certificate of Assumed Business Name
    - Washington: Active Business License
    - Oregon: Application For Registration **or** Current Renewal of Registration
    - Arizona: Active Trade Name Registration **or** Partnership Registration

    - Idaho: Certificate of Limited Partnership **or** Current Annual Report
    - Washington: Certificate of Limited Partnership or Current Annual Report
    - Oregon: Certification of Limited Partnership or Current Annual Report
    - Arizona: Active Trade Name Registration **or** Partnership Registration
  - o Limited Liability Partnership
    - Idaho: Statement of Qualification of Limited Liability Partnership or

Current Annual Report

- Washington: Certificate of Limited Liability Partnership or Current Annual Report
